

ORDINANCE NO. 3010 NEW SERIES

AN ORDINANCE OF THE COUNCIL OF THE CITY OF GLENDALE, MARICOPA COUNTY, ARIZONA, AUTHORIZING THE EXECUTION OF A WATER LINE EASEMENT LOCATED ADJACENT TO AZ GENERAL HOSPITAL ER AND DIRECTING THE CITY CLERK TO RECORD A CERTIFIED COPY OF THIS ORDINANCE.

WHEREAS, construction of the new water line has been completed and approved by the City and 83rd & Camelback, LLC, the owner, is granting a new water line easement to the City; and

WHEREAS, a new water line would benefit future development on 83rd Avenue and Camelback Road intersection and meet the domestic water demands and fire protection requirements of City Code.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF GLENDALE as follows:

SECTION 1. The City accepts an easement for the location of a new water line pursuant to the Conveyance of Easement, which is attached as Exhibit A. Upon the execution by the Grantor, 83rd & Camelback, LLC, a Delaware limited liability company, the City will have legal title to an easement for the purpose of operating, repairing, replacing, maintaining and removing a water line consistent with the City Code.

SECTION 2. The Council authorizes and instructs the City Manager to execute the Conveyance of Easement, which is attached as Exhibit A, granting a water line easement to the City.

SECTION 3. The City Clerk is instructed and authorized to forward a certified copy of this ordinance and Conveyance of Easement for recording to the Maricopa County Recorder's Office.

CONVEYANCE OF EASEMENT

For Ten Dollars and other valuable consideration, I or We, 83RD & Camelback, LLC, a Delaware limited liability company, do hereby convey to the City of Glendale, an Arizona municipal corporation, an easement to install, repair, operate, maintain and remove a water line and appurtenances ("facilities") upon, over and under the surface of the following described property:

Together with the right of ingress and egress to, from, across and along the Grantor's Property, and with the right to use lands adjacent to said easement during temporary periods of construction; the right to operate, repair, replace, maintain, and remove facilities and appurtenances from said premises; to add to or alter said facilities at any reasonable time; and to trim or remove any trees or shrubs that in the judgment of the City may interfere with the construction, operation or maintenance of said facilities.

By accepting this easement, the City of Glendale agrees to exercise reasonable care to avoid any damage to said real property above described.
