- 4) Their clucking, and mere presence, can cause dogs to bark incessantly. The noise can be a very real nuisance to shift-workers, people who work from home and households with infants or small children.
- 5) If not handled properly, Salmonella, a food-borne disease, can be transmitted to humans by touching chickens and gathering eggs. (Source: http://www.cdc.gov/ieatures/salmonellapoultry/
- 6) Coops and chickens may negatively affect a homeowner's ability to sell their home in a timely fashion and for a fair market price.






