

AMENDMENT NO. 1
NORTHERN PARKWAY LANDSCAPE MAINTENANCE
(City of Glendale Solicitation RFP 15-78, Contract No. C-10434)

This Amendment No. 1 ("Amendment") to the Northern Parkway Landscape Maintenance ("Agreement") is made this _____ day of _____, 2017, ("Effective Date"), by and between the City of Glendale, an Arizona municipal corporation ("City") and Somerset Landscape Maintenance, Inc., an Arizona corporation authorized to do business in Arizona ("Contractor").

RECITALS

- A. City and Somerset Landscape Maintenance, Inc. ("Contractor") previously entered into an agreement for landscape maintenance services, Contract No. C-10434, dated November 10, 2015 ("Agreement"); and
- B. City and Contractor wish to modify and amend the Agreement subject to and strictly in accordance with the terms of this Amendment.

AGREEMENT

In consideration of the mutual promises set forth herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the City and Contractor hereby agree as follows:

1. **Recitals.** The recitals set forth above are not merely recitals, but form an integral part of this Amendment.
2. **Term.** The term of the Agreement is unchanged and shall expire on November 9, 2017.
3. **Scope of Work.** The scope of work is hereby modified to include an additional 749,178 square footage area of service for the 303 Loop, in accordance with section 3.2 of solicitation RFP 15-78. All other provisions of the Agreement except as set forth in this Amendment shall remain in their entirety.
4. **Compensation.** The Contractor's compensation for the Project, including those furnished by its Subcontractors, will increase by \$26,221.00 annually and not exceed \$928,612.00 for the full term of the agreement.
5. **Insurance Certificate.** Current certificate will expire on January 16, 2017 and a new certificate applying to the extended term must be provided prior to this date to Materials Management and the Contract Administrator.
6. **Non-discrimination.** Contractor must not discriminate against any employee or applicant for employment on the basis of race, color, religion, sex, national origin, age, marital status, sexual orientation, gender identity or expression, genetic

characteristics, familial status, U.S. military veteran status or any disability. Contractor will require any Sub-contractor to be bound to the same requirements as stated within this section. Contractor, and on behalf of any subcontractors, warrants compliance with this section.

7. **No Boycott of Israel.** The Parties agree that they are not currently engaged in, and agree that for the duration of the Agreement they will not engage in, a boycott of Israel, as that term is defined in A.R.S. §35-393.
8. **Attestation of PCI Compliance.** When applicable, the Contractor will provide the City annually with a Payment Card Industry Data Security Standard (PCI DSS) attestation of compliance certificate signed by an officer of Contractor with oversight responsibility.
9. **Ratification of Agreement.** City and Contractor hereby agree that except as expressly provided herein, the provisions of the Agreement shall be, and remain in full force and effect and that if any provision of this Amendment conflicts with the Agreement, then the provisions of this Amendment shall prevail.
